Brokerage Fees My IPO sign up is free and there are no associated membership fees to maintain an account. You are not charged any fees when you purchase Offers and invest.	For publicly traded securities there is a \$10 trade fee charged if you enter trade online or 1% of trade value, plus \$10 commission if you call our trade desk to enter trade, should you buy shares in the open market (outside of an offering) or sell shares in the future, plus we pass along regulatory fees such as SEC and TAF fees as part of the "Commission/Service Fees". The SEC and TAF fees or "Service Fees" are very minimal charges.
